

State-Specific Addendum to the Privacy Policy Supplement for the Foureyes Tool Last Updated and Effective Date: June 16, 2025

This State-Specific Addendum to the Dealer's Privacy Policy Supplement for the Foureyes Tool (**"State Addendum"**) applies to residents of U.S. states with privacy laws that apply to the Dealer, who is the business and data controller of your personal information.

The scope of this State Addendum is the same as the scope of the relevant Dealer's Privacy Policy Supplement and is limited to the processing conducted by the Foureyes Tool on that Dealer's behalf. From time to time, Foureyes may update this Privacy Policy Supplement as described in the Changes to this State Addendum section below. Defined terms used but not defined in this State Addendum have the same meaning as defined in the Dealer Privacy Policy Supplement.

Depending on your state of residence, you may be able to exercise the following rights:

Right to Know The right to know what Personal information has a collected about you and how it is processed. Please note that **these rights are not absolute**. Requests may be refused, in whole or in part, where exceptions under applicable law apply. Additionally, a request may be refused if it is unfounded, repetitive, or excessive.

2. Exercising Your Rights

Submitting a Rights Request

To exercise any of your rights, please submit your rights request to the Dealer directly. Please review the Dealer's privacy policy for information regarding how to submit a data rights request and the process that the Dealer follows to respond to requests. Depending on your state of residence, an authorized agent or another third party may make data rights requests on your behalf.

Appeal

3. Collection and Disclosure of Personal Information

Foureyes is operating as a service provider/processor to the Dealer and is processing personal information on the Dealer's behalf. 

4. Sale, Targeted Advertising and Profiling

The Foureyes Tool does not (a) engage in the sale or sharing of personal information, as the term is defined under applicable state law, (b) collect or process personal information for purposes of targeted advertising, as the term is defined under applicable state law, or (c) engage in profiling of consumers in furtherance of automated decisions that produce legal or similarly significant effects. Foureyes does not sell, share or use for targeted advertising personal information of known minors under sixteen (16) years old.

5. Global Privacy Controls/Opt-Out Preference Signals

6. De-identified Data Disclosure

The Foureyes Tool may use de-identified data in some instances. Foureyes either maintains such data without attempting to re-identify it or treats such data as personal information subject to applicable law, unless such data is publicly available information and therefore would not be personal information under applicable law even without de-identification.

7. Changes to this State Addendum

Foureyes may update this State Addendum from time to time. When Foureyes updates this State Addendum, we will revise the "Last Updated and Effective Date" at the top of this State Addendum and post a link to the updated State Addendum. Changes to this State Addendum are effective when they are posted. If Foureyes makes any material changes, the Dealer will provide you with notice as required under applicable law. For example, the Dealer may send you an email or Foureyes may include an alert on this State Addendum. Please review this State Addendum and the Dealer Privacy Policy Supplement periodically to ensure you are aware of any such changes.



Additional Privacy Rights and Disclosures for Specific States California

The below addendum applies only to California residents and supplements the disclosures in this State Addendum above. This California addendum provides the Notice at Collection and describes additional rights provided for under the California Consumer Privacy Act (**"CCPA"**). *Notice at Collection*

Foureyes retains personal information for the purposes stated in the relevant Dealer's Privacy Policy Supplement, as directed by the Dealer and as required under applicable law. To determine how long Foureyes keeps personal information, we consider the amount, nature, and sensitivity of personal information, the reasons for which we collect and process the information, and applicable legal requirements.

The Foureyes Tool does not process sensitive personal information, as defined under the CCPA, without consent, or for purposes other than those specified in Cal. Civ. Code § 1798.121.

Additional California Privacy Rights

In addition to the rights described in the U.S. State Data Rights section above, California residents have the following additional data rights:

Right to Limit Use and Disclosure of Sensitive Personal Information	You have the right to request that the use and disclosure of sensitive personal information (as "sensitive personal information " is defined under the CCPA) be limited under certain circumstances.
Right Against Discrimination	You have the right not to be discriminated against because you have exercised your rights under California law.

Do Not Sell/Share Personal Information

The Foureyes Tool does not sell or share personal information, as those terms are defined under the CCPA, and does not sell or share personal information of known minors under sixteen (16) years old.

California "Shine the Light" Disclosure

The California "Shine the Light" law gives residents of California the right under certain circumstances to opt-out of the sharing of certain categories of personal information with third parties for their direct marketing purposes. The Foureyes Tool does not currently share or disclose personal information with third parties for their own direct marketing purposes.

Nevada

Under Nevada law, Nevada "consumers" (individuals who are seeking or acquiring goods/services for personal, family, or household purposes) may opt out of the sale of covered personal information. Foureyes does not currently sell covered information of Nevada consumers as defined under applicable Nevada law. You may submit an opt-out request by



sending your request to the relevant Dealer following the data rights submission procedures specified in the Dealer's privacy policy.
